EXECUTIVE SUMMARY

Confi-Chek was incorporated in 2000 and has been providing public records and commercial personal data as a service nearly 20 years. The Enformion online web portal is focused on providing personal data solutions to commercial and government customers.

The Enformion online platform integrates more than 6,000 data sources. The powerful algorithm connects billions of records to build comprehensive profiles about individuals. We make this data available through a web software application platform. We also offer a published Application Program Interface (API), and traditional batch data file exchange for integration with third party applications and our customers' own database applications.

Confi-Chek's story begins with roots in the private investigation and person locator services industry, providing data to a variety of industries, including law enforcement investigative, debt collection and financial services. Derivative markets and services were also established providing witness locator systems for law firms, assisting municipal and state government to communicate with constituents, augmenting law enforcement and private investigator's information systems. One of our largest customers, an armed forces branch, uses the Enformion service to maintain current contact information and regular outreach with recently separated soldiers that are subject to recall.

Our consumer business is established as the well-known Internet brand, PeopleFinders.com, and continues to enjoy strong commercial success.

To guard our data records, inclusive of more than 98% of the US adult population, Confi-Chek employs sound information and cyber security practices, including next generation firewall systems, minimum access network provisioning for employees, and multi-factor authentication to internal corporate systems and resources.

Technical Differentiators

Our proprietary algorithms analyze incoming data for variations that are to be expected between disparate data sources, accurately matching and appending the information to the identified individual, developing a personal profile.

Phone Numbers

Enformion platform provides one of the largest collections of landline and mobile phone records in the industry.

Archival Depth

Enformion has been aggregating individual telephone, address, and relationship histories for decades. We have retained this information, and all is searchable. For example, queries of an old address or telephone number from more than twenty years ago is easily resolved to the subject's current identity and personal profile.

Linkages and Relationships

This vast aggregation of current and historical data sets allows us to match telephone data, address records, relative and associate linkages to generate comprehensive profiles for each individual in our databases.

These linkages provide a broad-based investigative resource that combines other data features such as adverse criminal arrest, convictions, and court activities.

Business and Corporation Data

While many other competitive sources also have business and corporate information, Enformion specializes in linking principals on business registration filings to Enformion person profiles. A subject's business interests are identifiable from comprehensive reporting of our individual person profiles and registered business principals are linked to our corresponding person records.

We market our platform as a SaaS solution, presented as a web portal application suitable for interactive data discovery, data mining, and report generation.

Web Application Portal

Our Enformion Investigative web portal (Enformion online platform) subscription is offered through the GSA Schedule 70 contract with two pricing models.

This Software as a Service application delivers operational efficiency, information security, and bestin-breed data breadth in a feature rich platform that easily enables our customer to locate people, assets, businesses, relatives, licenses and comprehensive background information of adults in the United States.

The subscription offer also includes a Business Data Discovery service, with data sets inclusive of all US corporations and their affiliates, subsidiaries, and company officer information. Further, company officers can be investigated as to their personal information, known associates, contact, and address information.

The data content for each subscription pricing model is identical, we offer the different options to meet different anticipated usage volumes, customer needs, and budget.

Subscription Options

The **GSA Monthly Zero** features our base GSA-negotiated query and reporting in-app usage fees but does not have a monthly minimum fee.

The **GSA Monthly 25** includes a sizable discount on every in-app query and reporting fees for a \$25.00 monthly commitment per seat. The \$25.00 monthly fee is credited to in-app usage incurred on a monthly basis; any surplus does not roll over to the following month.

Law Enforcement Investigations

The Enformion online platform displays aggregated telephone and address histories for individuals, uncovering familial and close non-family relationships that develop over the subject's lifetime. When investigating a subject, or locating a fugitive, these relationships are critical to understand. Does an "ex" brother-in-law own a property near where the fugitive is suspected to be hiding? Does the suspected child pornographer own other properties or use other names and online personas? These are criteria easily discoverable by investigators.

Delinquent Tax Debt Skip Tracing

Designed for investigative research, support, and skip-tracing purposes, the online platform allows combinations of flexible inputs such as an age range, partial social security number, a last known city or address, or a previous phone number from years ago to determine an identity match and current whereabouts when limited information is available. The platform's strength is its archival depth, storing over 40 years of previous phone numbers and addresses for each individual and unique investigative insights. Combined with our data hygiene, our platform unique in its ability to research the backgrounds, relationships, and personal history of individuals.

Armed Forces Mustering and Roll Call

The Enformion service provides updated contact records via batch processing services for approximately 100,000 soldiers monthly

The Enformion online platform provides services for 120 military career counselors to regularly engage the same population of veterans, encouraging them to consider other career opportunities in the armed forces.

State governments can use Enformion to maintain National Guard and First Responder records, and aid in recruitment efforts.

Regulation and Enforcement

A major State of California regulatory enforcement agency uses the Enformion online platform to investigate the backgrounds of targeted companies and individuals, and to evaluate the reasonableness of civil case settlement offers.

Oil and Gas regulators are using Enformion to identify the current location of responsible corporations and principals for capped and damaged wellheads.
